#### INTRODUCTION

Appellant Contra Costa County Office of Education ("Appellant" or "CCCOE"), and Respondents California State Controller's Office, and California Department of Finance (collectively, "the Parties"), agree to a complete resolution of the above-captioned matter as follows:

### RECITALS

- A. Auditing firm Christy White Associates ("Auditor") conducted an audit of the Contra Costa County Office of Education's financial statements for the year ending June 30, 2018, the results of which were set forth in the Independent Auditors Report issued on or about June 30, 2018.
- B. In Audit Finding 2018-001, Auditor determined that Golden Gate Community School, a charter school operated by Appellant, did not meet the minimum instructional minutes required by Education Code section 47612.5(a)(1) for fiscal year 2017-2018, resulting in an apportionment penalty of \$81,830.
- C. On October 2, 2020, Appellant timely filed a request for formal appeal of Audit Finding 2018-001 ("the Appeal") pursuant to Education Code section 41344 subdivision (d), instituting the Appeal before the Education Audit Appeals Panel ("EAAP").
- D. To avoid the cost and uncertainty of litigation, the Parties to this case agree to completely resolve this dispute on the terms and conditions described below.

#### **AGREEMENT**

For the purpose of completely settling and resolving the Appeal of Audit Finding 2018-001, and subject to the EAAP's approval of this Stipulation and Settlement Agreement ("Agreement") pursuant to Paragraph 3, the Parties stipulate as set forth below:

1. Appellant shall repay in full satisfaction of Audit Finding 2018-011, the sum of \$81,830, without interest, in equal annual installments of \$10,228.75, per year, for an eight (8) year period, commencing with the first payment due by June 1, 2021, and by June 1 of each year thereafter, until final payment by June 1, 2028.
