RECITALS

- A. The independent auditing firm Robertson & Associates (Auditor) conducted an audit of the Appellant for the 2015-2016 fiscal year.
- B. In Audit Finding 2016-001, the Auditor determined that Appellant had hired a non-credentialed teacher and the teacher had not applied for credentialing until March 1, 2016. As a result, the Auditor disallowed \$81,066 received by Appellant for the 2015-2016 fiscal year, pursuant to the penalty calculation methodology in Education Code section 45037.
- C. Appellant timely filed a request for formal appeal of the foregoing audit finding pursuant to Education Code section 41344(d) instituting the appeal before the Education Audit Appeals Panel ("EAAP").
 - D. Finance intervened pursuant to Education Code section 41344.1, subdivision (b).
- E. To avoid the cost and uncertainty of litigation, the parties to this case agree to completely resolve this dispute on the terms and conditions described below.

AGREEMENT

For the purpose of completely settling and resolving the appeal of Audit Finding 2016-001, the parties agree as set forth below:

- 1. The disallowed amount of \$81,066 shall be reduced to the sum of \$40,533. The remaining balance shall be waived.
- 2. Appellant shall repay in full satisfaction of Audit Finding 2016-001 the sum of \$40,533, without interest, from Appellant's next principal apportionment following EAAP's approval of this stipulated agreement.
- 3. The stipulated agreement fully and completely resolves all claims, demands, appeals, obligations, or causes of action arising from or relating to Audit Finding 2016-001. Accordingly, the parties expressly waive any right or claim to assert or pursue thereafter any claim, demand, obligation, and/or cause of action relating to Audit Finding 2016-001.
